# **ABOUT THIS DEGREE PROGRAM**

### A PROGRAM TO FUEL YOUR FUTURE

The Master of Public Administration (MPA) program focuses on concepts and skills needed to effectively manage organizations operating outside of the traditional business environment.

The MPA program requires successful completion of 39 semester credit hours, and offers students a choice of two emphases: government management and healthcare management. Students must declare an emphasis prior to graduation; successful completion of an emphasis is noted on transcripts. Total program length varies based on the number of courses taken per eight-week session.

- Healthcare Management
- Government Management

### **GOVERNMENT MANAGEMENT EMPHASIS**

If your professional goals include lending your managerial expertise to city, county, state or federal governments, the MPA with Government Management may be right for you.
