## REQUIREMENTS FOR UNDERGRADUATE STUDENTS ENROLLING IN KELLER COURSES



Note: Enrollment in graduate-level courses offered by the University's Keller Graduate School of Management is limited to undergraduate students in DeVry's bachelor's degree program in Business Management.

To enroll in a Keller course, students in an eligible program must be – and remain – in good academic standing, have completed at least 89 semester-credit hours applicable to their enrolled program, have a cumulative grade point average of 3.0 or higher at the time of enrolment and receive approval from the appropriate academic administrator.

Generally, qualified undergraduate students may enroll in a maximum of three Keller courses (nine semester-credit hours) provided they earn a C or higher in their first, and in each prior, Keller course. Undergraduate students' enrollment in Keller courses is limited to Keller courses designated with a 'G' (e.g., MGMT591G).

Undergraduate students enrolling in Keller courses are charged undergraduate tuition and follow undergraduate academic engagement (attendance) and financial aid policies. They also follow the undergraduate grading scale. Students who wish to apply prior graduate-level credit to fulfill an applicable elective credit hour requirement in their bachelor's degree program must meet prior learning credit requirements specified in the Keller catalog. Those who must repeat a course for any reason must receive approval for the repeat from the appropriate academic administrator and are limited to one course repeat.

Undergraduate students should note that enrollment in a Keller course does not constitute admission to Keller Graduate School of Management. Students choosing to continue their education at Keller must meet the University's graduate admission and transfer credit requirements for their graduate-level courses to be applicable to a Keller program.
