Award Guidelines, Structure and Process	Disbursement	Qualifying students may receive up to either \$10,000 or \$5,000 (maximum lifetime award). The \$10,000 scholarship award winner will receive this amount up to two (2) years. The \$5,000 scholarship award winners will receive this amount for up to one (1) year. The award will be divided into either three or six disbursements with the following breakdown per semester. <p><b>\$10,000 winner over 2 years:</b></p> <ul style="list-style-type: none"> <li>Year 1: \$1,667 in Fall 2024, \$1,667 in Spring 2025, \$1,666 in Summer 2025</li> <li>Year 2: \$1,667 in Fall 2025, \$1,667 in Spring 2026, \$1,666 in Summer 2026</li> </ul> <p><b>\$5,000 winner over 2 years:</b></p> <ul style="list-style-type: none"> <li>Year 1: \$1,667 in Fall 2024, \$1,667 in Spring 2025, \$1,666 in Summer 2025</li> </ul>

<sup>4</sup>DeVry University (DVU) in conjunction with your employer is offering employees who are new or readmit DeVry students to take a DVU 3-credit-hour course for academic credit at no tuition cost. Those interested in a 4-credit-hour course may enroll. 3 credit hours would be complimentary, and the student will be responsible for the tuition of the remaining credit hour. Students are responsible for all other fees and charges, including books and the Learning Management System (LMS) fee. Employees must apply to DVU and be admitted and accepted as a student, meet all prerequisite and course requirements, and take the complimentary course within their first session of enrollment. Students who place at foundations level may not participate in the program until they have successfully completed their foundational prep coursework. Check with your employer's human resources department to confirm effective dates and eligibility for your employer's Jumpstart Your Education program with a complimentary course.

<sup>5</sup>Dependents who may benefit from family tuition savings include: spouse, biological child, stepchild, legally adopted child, child for whom the employee is a court appointed guardian, child of a domestic partner, and adoptive or biological parents of the eligible employee. Dependents are also defined as a domestic partner in a committed long-term relationship. Neither party can be legally married to other individuals.
